

## RAD Project-Based Voucher WAIT LIST OPENING – WEDNESDAY, JULY 14, 2021

The Housing Authority of Grays Harbor County (HAGHC) will open the HCV RAD Project-Based Voucher wait list from Wednesday, July 14, 2021, at 8:15 a.m. – Friday, July 30, 2021 at 4:30 p.m.

The preliminary application process will be different this year for the safety of applicants and staff. Wearing a mask and social distancing is required at all times and will be strictly enforced.

## 1. <u>Pick up application in advance – Starting Tuesday, July 13 at 8:10 a.m.</u>:

Applicants can complete the form in advance.

Applications can be picked up at 602 East First Street, Aberdeen - **Front Entrance**, starting on July 13, at 8:10 a.m.

Applications WILL NOT BE ACCEPTED UNTIL Wednesday, July 14 – no exceptions.

All applications will be reviewed and received on a first come, first serve basis. Your place on the waitlist will depend on the date and time stamp.

## 2. <u>Submit Completed Applications – Starting Wednesday, July 14, at 8:15 a.m. through July 30,</u> 2021 at 4:30 p.m.:

Applications will be accepted at 602 East First Street, Aberdeen – **Back Parking Lot**, starting on Wednesday, July 14 at 8:15 a.m.

HAGHC staff will provide directions to applicants on the procedures when entering the back parking lot. Applicants are required to wear a mask and social distance a minimum of 6 feet at all times while waiting in line.

*If there are any questions or if an accommodation is needed, please call 360.533.0653 or email* <u>roma@hagh.com</u> **IS THERE A PREFERENCE?** – Applicants who live or work in Grays Harbor will be eligible for a Residency Preference and will be placed above applicants on the waitlist that live outside of Grays Harbor County.

HOW SOON WILL I BE HOUSED? — This is only a **preliminary** application. The estimated wait time is **2-4 years** and may depend on vacancies. We house people based on their place on the waitlist may depend on the completeness of the verifications provided during the eligibility process.

**I DON'T KNOW IF I WILL QUALIFY** – This is only a **preliminary** application. Everyone is welcome to apply, including emancipated minors.
